Paying contributions

To be SuperStream compliant and avoid potential ATO penalties, all employers should make their employee super contributions and payments in an approved electronic format.

You can make your employee super contributions via a clearing house facility (which allows you to pay multiple funds in one single transaction).

Non-compliant payment methods

Please note that the following payment methods are not compliant for employers with 20 or more employees:

- cheques
- electronic funds transfers which do not include a corresponding unique payment reference number.

Additional data requirements

You're also required to include some new data in your payroll file to facilitate electronic processing under SuperStream, including:

- the unique superannuation identifier (USI) for APRA-regulated funds (Local Government Super USI is: LGS010IAU)
- the super fund's bank account details
- electronic service address
- Australian Business Number (ABN).

1. LGSS Pty Limited (ABN 68 078 003 497) (AFSL 383558) is the Trustee of Local Government Super (ABN 28 901 371 321).
2. Local Government Super is a resident regulated superannuation scheme within the meaning of the *Superannuation Industry (Supervision) Act 1993*.
3. Local Government Super is not, nor has ever been, subject to direction under Section 63 of the *Superannuation Industry (Supervision) Act 1993* not to accept any contributions from an employer sponsor.
4. It is the intention of the Trustee that Local Government Super will be administered so that it will continue to be treated as a complying superannuation scheme.
